107 g/L GLUTARALDEHYDE,

78 g/L DIDECYLDIMETHYLAMMONIUMCHLORIDE as the only active

constituents.

Critical Use Comments:

- Thoroughly clean all surfaces before treatment.
- Apply to farm equipment or surfaces as a drench or spray using knapsack or powered sprayer.
- Use a sufficient spray volume to wet the entire surface of the equipment and surfaces.
- The surface being treated must remain wet for the full exposure time of 1 hour.

Re-Entry Directions:

DO NOT re-enter treated areas for 2 hours after surface disinfection.

If prior entry is required, wear all personal protective clothing, including gloves and respirator, as recommended in the product safety directions on the label.

DO NOT come into contact with treated surfaces for 30 minutes after the full exposure time has elapsed.

WARNING - Contains glutaraldehyde which may cause asthma and/or respiratory and/or skin sensitisation. Sensitive workers should avoid contact with this substance.
